	If parent must cancel a driving lesson, the cancellation must be made a minimum of <u>4 days</u> prior to the scheduled appointment. A fee of \$49.00 may be charged if cancellations are not timely. The fee shall apply if Student fails to appear for, or for any reason is not prepared to take, the driving lesson (i.e. does not have temporary permit). The Driving School may cancel a driving lesson due to adverse weather conditions or hazardous road conditions. The Driving School shall furnish a licensed instructor and a motor vehicle for instruction. Ohio rules require the Driving School to make BTW training available no later than six (6) months after BTW training begins () Should Student be unable to attend available training sessions offered, the Driving School is relieved of the aforementioned obligation and this agreement expires. The Driving School reserves the right to cancel this agreement should Student's conduct indicate a lack of responsibility deemed necessary by the Driving School to safely operate a motor vehicle.
